# Agreement for Waiver, Release, Indemnification & Assumption of Risks

I, the above named **Participant** being above the age 18, or the **Parent** of the above named Participant who is under the age 18, and in consideration for attending, participating and viewing **Summer Soul Surf Camp**, hereby agree as follows:

I acknowledge and understand that surfing is a hazardous and dangerous activity that requires strenuous exercise and various degrees of skill and experience for different water conditions; I understand that these activities can result in serious injury to the person and damage to property; I also understand that these risks, hazards and dangers are further increased when other persons, whether of the same level of experience or skill or not, are using the same facilities; I am aware of the risks, hazards and dangers of personal injury, death and disability inherent in viewing and/or participating in any surfing event;

**I VOLUNTARILY ASSUME SUCH RISKS.** In consideration for attending, participating and/or viewing activities and events while at Summer Soul Surf Camp, I hereby agree to release and forever discharge the State of California/ California State Parks ("California State Parks"), Summer Soul Surf Camp Co ("Summer Soul"), and their respective agents, servants, employees, officers, directors, trustees, affiliates, parents, subsidiaries, and all other persons or entities on its behalf, from any and all claims, actions, damages, liability, costs or expenses and attorney fees which are related to, arise out of, or are in any way connected to my/my minor child's attendance and participation in Surf Camp activities, use of equipment or property supplied by Summer Soul, or my/my minor child's presence at Surf Camp, whether or not such claims, actions, damages, liability, costs or expenses are caused by the negligence of the California State Parks, Summer Soul Surf Camp staff. I agree to hold harmless and indemnify California State Parks, Summer Soul and their respective agents, servants, employees, officers, directors, trustees and all other persons or entities on its behalf, from any and all liability for damage to any third party resulting from my/my minor child's involvement at Surf Camp. By this Agreement, it is my intention to surrender and waive any rights to sue or exercise any legal right to seek damages from California State Parks, Summer Soul and their respective agents, servants, employees, officers, directors, trustees, affiliates, parents, subsidiaries, and all other persons or entities acting on its behalf. I give my consent and permission to California State Parks, Summer Soul to obtain, on my behalf of myself or my minor child, any emergency medical treatment in case of sickness, accident or injury and to secure such medical attention at my expense. This Agreement applies to my participation in all Surf Camp activities and programs, including but not limited to, open surfing, other water-related activities, practice sessions, instructional sessions, competitions and activities directed by any representative of California State Parks, Summer Soul Surf Camp Co including viewing any of the aforementioned activities. This Agreement covers all of the aforementioned activities regardless of whether the activities are conducted at the Surf Camp or at any other location where activities sponsored by Summer Soul may take place. This Agreement will be effective and binding upon my heirs, agents, personal representatives and assigns. Any dispute between the parties relating to this Agreement or its interpretation will be resolved by binding arbitration, in accordance with the commercial arbitration rules of the American Arbitration Association, in Orange County, California. The arbitrator(s) will be limited to awarding compensatory damages and will have no authority to award punitive, exemplary or similar type damages. **I UNDERSTAND THAT I AM GIVING UP THE RIGHT TO A JURY OR COURT TRIAL.** I hereby certify that I am over 18 years of age. I have carefully read the foregoing and acknowledge that I understand and agree to all of the above terms and conditions. I have had the opportunity to ask questions regarding this Agreement and the effect of the same. I am aware that by signing this Agreement, I assume all risks and waive and release certain substantial rights that I may have or possess. **Promotional Use of Images:** I hereby agree that Summer Soul may use film or photographic images of me at Surf Camp for promotional and/or commercial purposes and without compensation to me, and I consent to the use of my name and likeness for such use in any media whether now known or hereafter devised, throughout the world in perpetuity, without further approval by me.
